In 2020, Resilience1220 provided 1,278 hours of individual counseling, reaching 249 youth ages 12-20. We have invested 289 hours facilitating support groups, reaching 208 youth. The various support groups include Beyond the Rainbow, a safe and affirming group for those who want to learn, listen, or get support on LGBTQ+ issues, and a grief group for youth who have suffered the loss of a loved one at any time in their life. Support groups aim to decrease the isolation youth feel by providing safe spaces to discuss difficult issues. Resilience1220's Conversations & Connections series provides parents with information and resources on various topics, including anxiety, self harm, & how to support LGBTQ+ youth. The Conversations and Connections series promotes open discussions about the issues affecting youth, while diminishing the isolation many families feel. Resilience1220's programs are strengthening youth, their families, & our community by providing spaces that encourage open discussion about the social, emotional, and mental health issues affecting our youth.
